BILL NO. 11 – AN ORDINANCE ADOPTING A BUDGET, AS AMENDED, FOR THE CITY OF TRENTON, MISSOURI, FOR FISCAL YEAR BEGINNING MAY 1, 2021 AND ENDING APRIL 30, 2022 WITH SAID BUDGET FIXING EMPLOYEE AND OFFICER POSITIONS AND COMPENSATION FOR SAID FISCAL YEAR FOR THE SAME AND AUTHORIZING EQUIPMENT PURCHASES.

BILL NO. 12 - AN ORDINANCE OF THE CITY OF TRENTON, MISSOURI APPROVING AN AGREEMENT BY AND BETWEEN THE CITY OF TRENTON, MISSOURI AND JD BISHOP CONSTRUCTION, LLC FOR THE WATER TREATMENT PLANT FRONT STEP REPLACEMENT PROJECT BETWEEN THE CITY OF TRENTON AND JD BISHOP CONSTRUCTION, LLC IN THE CITY OF TRENTON AND AUTHORIZING THE MAYOR AND CITY CLERK OF THE CITY OF TRENTON, MISSOURI, TO EXECUTE THE SAME BY AND ON BEHALF OF SAID CITY.

BILL NO. 16 - AN ORDINANCE OF THE CITY OF TRENTON, MISSOURI APPROVING AN AGREEMENT BY AND BETWEEN THE CITY OF TRENTON, MISSOURI AND CHALLENGER FENCE COMPANY FOR THE NORTH SUB STATION FENCING PROJECT BETWEEN THE CITY OF TRENTON AND CHALLENGER FENCING COMPANY IN THE CITY OF TRENTON AND AUTHORIZING THE MAYOR AND CITY CLERK OF THE CITY OF TRENTON, MISSOURI, TO EXECUTE THE SAME BY AND ON BEHALF OF SAID CITY.

BILL NO. 17 - AN ORDINANCE OF THE CITY OF TRENTON, MISSOURI APPROVING A NON- FEDERAL REIMBURSABLE AGREEMENT BY AND BETWEEN THE CITY OF TRENTON, MISSOURI AND DEPARTMENT OF TRANSPORTATION FEDERAL AVIATION ADMINISTRATION TO PROVIDE A COMMISSIONING FLIGHT INSPECTION AND A SPECIAL FLIGHT INSPECTION AT THE TRENTON MUNICIPAL AIRPORT BETWEEN THE CITY OF TRENTON AND DEPARTMENT OF TRANSPORTATION FEDERAL AVIATION ADMINISTRATION IN THE CITY OF TRENTON AND AUTHORIZING THE MAYOR AND CITY CLERK OF THE CITY OF TRENTON, MISSOURI, TO EXECUTE THE SAME BY AND ON BEHALF OF SAID CITY.

BILL NO. 18 - AN ORDINANCE DECLARING THE RESULTS OF THE GENERAL ELECTION HELD IN THE CITY OF TRENTON, MISSOURI, ON APRIL 6, 2021, FOR THE ELECTION OF ONE CITY COUNCILMAN FROM EACH OF THE FOUR WARDS OF THE CITY OF TRENTON, MISSOURI, FOR A REGULAR TERM OF TWO YEARS AND THE QUESTION: SHALL THE CITY OF TRENTON IMPOSE A LOCAL USE TAX AT THE SAME RATE AS THE TOTAL LOCAL SALES TAX RATE, CURRENTLY 2.625%, PROVIDED THAT IF THE LOCAL SALES TAX RATE IS REDUCED OR RAISED BY VOTER APPROVAL, THE LOCAL USE TAX RATE SHALL ALSO BE REDUCED OR RAISED BY THE SAME ACTION? A USE TAX RETURN SHALL NOT BE REQUIRED TO BE FILED BY PERSONS WHO PURCHASE FROM OUT-OF-STATE VENDORS DO NOT IN TOTAL EXCEED TWO THOUSAND DOLLARS IN ANY CALENDAR YEAR.
