Motion by Councilmember Crawford second by Councilmember Briggs that Bill No. 81 be introduced, AN ORDINANCE AMENDING SECTION 507.080, "SCHEDULE OF FEES" OF CHAPTER 507 ENTITLED "MINIMUM STANDARDS FOR THE MAINTENANCE OF NON-OWNER OCCUPIED DWELLINGS" OF TITLE V ENTITLED "BUILDING AND CONSTRUCTION" OF THE TRENTON CITY CODE, which was read. Motion by Councilmember Crawford second by Councilmember Briggs that Bill No. 81 be passed to the second reading placed upon final passage and voted on. Motion carried. Motion by Councilmember Mlika second by Councilmember Briggs that Bill No. 83 be passed to the second reading placed upon final passage and voted on. Motion carried.
