REPORTS

BILL NO. 3

Motion by Councilmember Smith second by Councilmember Mlika that Bill No. 3 be introduced, AN ORDINANCE OF THE CITY OF TRENTON, MISSOURI APPROVING A CONTRACT BY AND BETWEEN THE CITY OF TRENTON, MISSOURI AND SHULER CONCRETE AND CONSTRUCTION LLC FOR THE REMOVAL AND REPLACEMENT OF A CONCRETE DRIVEWAY LOCATED AT THE TRENTON FIRE DEPARTMENT IN THE CITY OF TRENTON AND AUTHORIZING THE MAYOR AND CITY CLERK OF THE CITY OF TRENTON, MISSOURI, TO EXECUTE THE SAME BY AND ON BEHALF OF SAID CITY, which was read. Motion by Councilmember Smith second by Councilmember Mlika that Bill No. 3 be passed to the second reading placed upon final passage and voted on. Discussion was held. Motion carried. A copy of Bill No. 3 was made available for public inspection prior to this meeting by being posted at City Hall on February 5, 2021. The following vote was taken. passed, numbered Ordinance No. 2021-3, signed and approved by the Mayor and attested by the City Clerk.

Motion by Councilmember Briggs second by Councilmember Dolan to accept the Mayor's appointment of Jason Shuler to the Police Personnel Board. Motion carried.

Discussion was held of refinancing 2012, 2014 and 2018 loans.

Motion by Councilmember Smith second by Councilmember Briggs to authorize Ron Urton to sign the Acknowledgement with D.A. Davidson to refinance the bonds. Motion carried.

Discussion was held concerning purchasing a used dump truck for the Street department. They found one for \$39,500.00.

Motion by Councilmember Briggs second by Councilmember Mlika to purchase the used dump truck for the street department for \$39,500.00. Motion carried.

Discussion was held concerning purchasing a pickup for the sewer department. Two bids were presented. One for a Ford for \$27,937.00 and the other a Chevy for \$25,986.00.

Motion by Councilmember Brewer second by Councilmember Mlika to purchase the Chevy for \$25,986.00. Motion carried.

A police training agreement was presented to the Council. Councilmember Humphreys said he would like #1 changed like #6.

Motion by Councilmember Briggs second by Councilmember Brewer to approve the police training agreement with the changes requested by Councilmember Humphreys. Motion carried.
